

AFFIDAVIT OF ANNUAL ASSESSMENT WORK FOR

TO WHOM IT MAY CONCERN:

Please take notice that W. L. Wilson, being first duly sworn, says that in excess of \$8,600.00, being more than \$100.00 per unpatented mining claim (identified below), was expended for labor and improvements on or with respect to such claims, consisting of initiation and pursuing a drilling program, the construction of drill sites and the building and improvements of roads to gain access to said claims and facilitates the drilling program. Drilling of 77 air rotary holes, aggregating more than 8,500 feet, as a part of the exploration and development project, was performed on the Red Iron and Johnnie Claims, and on the Windfall, Windfall Fraction and the 2G patented claims. Roads and road improvements were constructed on the above claims and on the Rustler No. 2 patented claim, on the Gold and the Gold No. 1, the W-31, the Gossan, the Sadie No. 5 and the F-130 and F-128 Claims. In addition, portions of the access road constructed leads across sections of unappropriated public lands from portions of the said claims to other of such claims.

All of the claims listed below are contiguous and adjacent and form a unified block of claims all of which are owned or under lease-option to Idaho Mining Corporation in whose behalf the above expenditures were made. The drill program and the road building improved and benefited the entire block of claims and each of the individual claims forming such block.
