

QUITCLAIM DEED TO JOINT TENANTS

THIS INDENTURE, made and entered into this 7th day of September 1970, by and between DALE WYRAUCH and OTIS EAST of Long Beach, California, and CHARLES JANACEK and CRICKET GONZALEZ and DOYLE COLEMAN of Rogerson, Idaho, and GEORGE BURGESS, LEONARD EMERSON and D.D. LAWLEY, of Twin Falls, Idaho, first parties, and ALEX CAMPOURIS and ISABEL CAMPOURIS, whose address is 423 Maud Avenue, San Leandro, California, second parties, as joint tenants with right of survivorship,

W I T N E S S E T H:

That the said first parties, for and in consideration of the sum of TEN DOLLARS (\$10.00), lawful money of the United States of America, to them in hand paid by the said second parties, and other good and valuable consideration, the receipt whereof is hereby acknowledged, do by these presents remise, release and quitclaim unto the said second parties, as joint tenants with right of survivorship, and not as tenants in common, and to the assigns of said second parties, and to the survivor of them, and to the heirs, executors, administrators and assigns of the survivor, all of the first parties' title and interest in and to that certain unpatented placer mining claim located in the Bullion Mining District, in the County of Eureka, State of Nevada, more particularly described as follows, to-wit:

Unpatented Placer Mining Claim known as MARIE NO. I. located in the SW $\frac{1}{4}$ of Section 16, Township 30 North, Range 48 East, M.D.B.&M; which Certificate of Location of Placer Claim on MARIE NO. I. was recorded on Sept. 29, 1969 in Book 32 of Official Records at page 576, Eureka County Recorder's Office, Eureka, Nevada.

Together with the dips, spurs and angles, and also all the metals, ore, rock and earth therein; and all rights, privileges and franchises thereto incident, appendant and appurtenant, or therewith usually had and enjoyed; also all and singular, the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining, and the rents, issues and profits thereof.

TO HAVE AND TO HOLD the said premises, together with the appurtenances, unto the said second parties, as joint tenants with right of survivorship, and not as tenants in common.

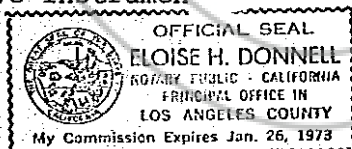

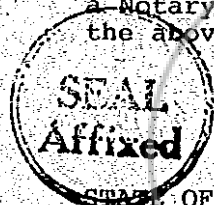
