AMENDED CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN:

That Three Flags Mining Company, a Utah Corporation, now owners of the Sheep Creek No. 2 Lode Claim, in order to clarify the intent of all predecessors in respect to the Laws of the United States and the State of Nevada, do hereby make and file this Amended Certificate of Location to supersede all previous location or amended location certificates.

Now Then: Three Flags Mining Company does recognize that the Sheep Creek No. 2 Lode Claim was originally located by Leon Hansen and Arthur Hansen April 9, 1957 and in all subsequent locations by Leon Hansen and Arthur Hansen did perform the proper location work and protect said claim by proper assessment work as did their successors.

Let It Be Known: The Sheep Creek No. 2 Lode Claim is of irregular shape and bent to conform with natural topography and the intended side centers act as corners in the bending of the claim.

The general trend of the vein or lode is Northeasterly and Southwesterly.

Now Then: The Sheep Creek No. 2 Lode Claim is setuate in Sections' 11 and 14, T.35N., R.50E., M.D.B. and M., Lynn Mining District, Eureka County, State of Nevada.

The Northwest Corner, a stake marked N.W.Cor., is approximately N.76°59'W., a distance of 2.212' from the Southeast Corner of Section11. The claim lies 500' in a Northeasterly direction from the location notice and 850' in a Southwesterly direction with 300' being claimed on each side of the vein or lode at the Northeast endline and 226' being claimed on each side of the vein or lode at the Southwest Endline.
