

## AMENDED CERTIFICATE OF LOCATION

## NOTICE IS HEREBY GIVEN:

That Three Flags Mining Company, a Utah Corporation, now owners of the Open Fraction Lode Claim, in order to clarify the intent of all predecessors in respect to the Laws of the United States and the State of Nevada, do hereby make and file this Amended Certificate of Location to supersede all previous location or amended location certificates.

Now Then: Three Flags Mining Company does recognize that the Open Fraction Lode Claim was originally located by Tom P. Costas and Arthur Blake Thomas June 15, 1963 and did perform the proper location work and protect said claim by proper assessment work as did their successors.

Now Then: The Open Fraction Lode Claim is situate in Section 11, T.35N., R.50E., M.D.B. and M., Lynn Mining District, Eureka County, State of Nevada.

The general trend of the vein or lode is easterly and westerly.

The Southwest Corner, a stake marked S.W.Cor., is approximately N.58°38'W., a distance of 2,135' from the Southeast Corner of Section 11. The claim lies 100' in a west direction from the Location Notice and 1,400' in a East direction with 300' being claimed on each side of the vein or lode.

Beginning at the Southwest Corner, a stake marked S.W.Cor., thence East a distance of 750' to the South Side Center, a stake marked South S.C., thence east a distance of 750' to the Southeast Corner, a stake marked S.E.Cor., thence North a distance of 600' to the Northeast Corner, a stake marked N.E. Corner, thence West a distance of 750' to the North Side Center, a stake marked North S.C., thence West a distance of 750' to the Northwest Corner, a stake marked N.W.Cor., thence South a distance of 600' to the Southwest Corner the point of beginning

The Open Fraction Lode Claim is bound on the Northeast by the Rita K and Tira K No.1 Lode Claims, bound on the South by the Triangular Fraction No. 2, Sheep Creek No. 1, and Jim No. 2 Lode Claims.

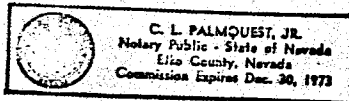
