claims by other persons and corporations.


That all of said work was done and performed for the benefit of each and all of the contiguous unpatented lode mining claims hereinabove named.

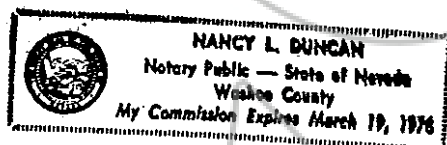
