ARTICLES OF INCORPORATION

of

RESOURCE LEGISLATURE RESEARCH

The name of the corporation is Resource Legislature Research.

The principal office of the corporation, in Nevada, is to be located at Route 2, Box 2, Austin, Nevada, 89310.

The corporation may engage in any lawful activity, and shall have perpetual existence.

The total authorized capital stock of the corporation shall consist of Twenty-four Thousand Nine Hundred and Fifty (24,950) shares of common stock having a par value of One Dollar (\$1.00) per share.

The common stock of the corporation shall be fully paid and non-assessable.

The private property of the stockholders shall not be liable for the debts of the corporation.

The members of the governing board of this corporation shall be styled "Directors". The first board of directors of this corporation shall consist of three (3) members, but the number may be increased from three (3) to fifteen (15) members.
