between the dates of August 16 and September 18, 1972, and consisted of geological and geochemical surveys over all of the above listed mining claims. Such work consisted of night-time lamping of the area by means of an ultra-violet light to determine the possible presence of tungsten; and a study of the stream sediments in Fourmile canyon for heavy metals. The basic findings are: (1) trace amounts of scheelite were found in several areas along the contacts and in association with the gold mineralization; and (2) no significant heavy metal anomalies were found except near contacts.

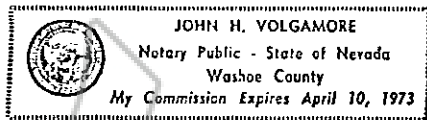
