

GRANT, BARGAIN AND SALE DEED

THIS INDENTURE, made and entered into this 10<sup>th</sup> day of October, 1972, by and between ROY L. ASH, of Los Angeles, California, First Party, and CHARLES B. THORNTON, of the same place, Second Party,

W I T N E S S E T H:



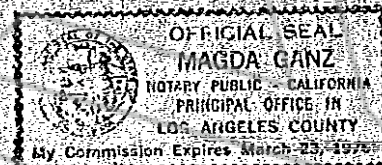
