Sixty-two and one-half percent (62%) of an undivided interest, as tenant in common, to ALBERT R. HECHINGER;

Thirty-seven and one-half percent (37½%) of an undivided interest, as tenant in common, to ALBERT R. HECHINGER, Trustee, in trust for the following uses and purposes:

The Trustee shall pay to or apply for the benefit of

JOEL I. HECHINGER, son of said decedent, the net income of the

Trust Estate and in addition thereto, such sums out of principal

Upon any division or partial or final distribution of the property of the Trust Estate, as herein provided, the Trustee may divide or distribute such property in kind, including undivided interests therein, or in his absolute discretion the Trustee may sell all or any part of such property and make such division or distribution in cash or partly in cash and partly in kind; and the decision of the Trustee as to what constitutes a proper division of the Trust Estate either prior to or upon any distribution thereof shall be binding upon all of the beneficiaries.

The Trustee is authorized to retain in the Trust, for such time as he may deem advisable, any property received by him hereunder, whether or not of the character permitted by law for

Trustee shall have the power, with respect to the property of the Trust Estate or any part hereof, and upon such terms and in such manuer as he may deem advisable, to sell, convey, exchange, convert, improve, repair, manage, operate and control; to lease for terms within or beyond the term of this Trust and for any purpose, including exploration for and removal of gas oil and other minerals; to borrow money for any Trust purpose, and to encumber or hypothecate by mortgage, deed of trust, pledge or otherwise; to carry insurance of such kinds and in such amounts as the Trustee may deem advisable at the expense of the Trust; to compromise or otherwise adjust any claims against or in favor of the Trust; to commence or defend such litigation with respect to the Trust or any property of the Trust Estate as he may deem advisable, at the expense of the Trust; to invest and reinvest the Trust funds in such property as the Trustee may deem advisable, whether or not of the character permitted by law for the investment of Trust funds, and with respect to securities held in the Trust, to vote, give proxies and pay assessments or other charges, to participate in foreclosures, reorganizations, consolidations, mergers and liquidations, and incident thereto to deposit securities with and transfer title to any protective or other committee upon such terms as the Trustee may deem advisable, and to exercise or sell stock subscription or conversion rights; and the Trustee shall have such additional powers as may now or hereafter be conferred upon him by law or as may be necessary to enable the Trustee to administer this Trust in accordance with the provisions of said Will of said decedent, subject to any limitations thereof that may be provided for in said Will.
