The Petition for Preliminary Distribution of SANTA MONICA BANK, as Administrator-With-The-Will-Annexed of the above named deceased (which petition was erroneously entitled Petition for Approval of Distribution Agreement; and Petition for Preliminary Distribution), came on regularly for hearing in Department 11 of the above entitled Court on February 29, 1972, before the Honorable NORMAN R. DOWDS, Judge Presiding, the Court sitting without a jury, which was expressly waived. JEROME SCHWARTZ and BRIAN J. KENNEDY appeared as co-counsel for petitioner SANTA MONICA BANK, STEPHEN R. RYKOFF appeared as attorney for ALBERT R. HECHINGER and JOEL IRA HECHINGER, having previously filed written Objections to said petition. THOMAS J. GAMBLE of IRSFELD, IRSFELD & YOUNGER appeared as attorneys for PATRICK J. KIGHTLINGER, Executor of the Will of MAMIE JANE HECHINGER. Deceased, having previously filed Points and Authorities in Opposition to the Objections to said petition. STANLEY L. HECHINGER appeared in propria persona.

Evidence, both oral and documentary, having been introduced, the cause having been argued orally and thereafter having

1 been duly submitted for decision, and the Court having examined
 2 said petition and other pleadings filed in connection therewith
 3 and in opposition thereto and having heard the evidence, and the
 4 Court having heretofore made and caused to be filed its written
 5 Findings of Fact and Conclusions of Law, finds that due notice of
 6 the hearing of said petition has been given as required by law,
 7 that ALBERT R. HECHINGER, Trustee named in the Will of said
 8 FERDINAND HECHINGER hereinbelow described, has consented in
 9 *that an Administrator Tax Attorney has consented to the preliminary dist.*
 9 writing on file herein to serve as such Trustee, and hereby orders
 10 preliminary distribution of certain assets of the estate of said
 11 FERDINAND HECHINGER, as follows:

12 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that prelim-
 13 inary distribution of the assets hereinbelow described be made,
 14 in accordance with the Last Will and Testament of FERDINAND
 15 HECHINGER, dated the 9th day of September, 1968, and duly ad-
 16 mitted to probate herein, as follows:

17 Sixty-two and one-half percent (62½%) of an undivided
 18 interest, as tenant in common, to ALBERT R. HECHINGER;

19 Thirty-seven and one-half percent (37½%) of an undivided
 20 interest, as tenant in common, to ALBERT R. HECHINGER, Trustee,
 21 in trust for the following uses and purposes:

22 The Trustee shall pay to or apply for the benefit of
 23 JOEL I. HECHINGER, son of said decedent, the net income of the
 24 Trust Estate and in addition thereto, such sums out of principal
 25 of the Trust Estate as the Trustee in his sole discretion shall
 26 deem necessary to provide for the support and maintenance of said
 27 JOEL I. HECHINGER. Such principal invasion may also be made by
 28 said Trustee in his sole discretion to terminate the Trust earlier
 29 than the mandatory distribution provisions hereinafter set forth.

30 Upon said JOEL I. HECHINGER attaining the age of twenty-
 31 five (25) years, one-half (½) of the principal and undistributed
 32 income shall be distributed to him; upon his attaining the age of

1 thirty (30) years, the balance of the principal and undistributed
2 income shall be distributed to said JOEL I. HECHINGER and the
3 trust created for him shall terminate.

4 In the event that said JOEL I. HECHINGER shall not sur-
5 vive distribution of the Trust Estate, then and in such event the
6 principal and undistributed income of the Trust created shall be
7 distributed to his issue per stirpes or, if he shall die failing
8 issue, then to ALBERT R. HECHINGER, son of said decedent.

9 Notwithstanding the foregoing, if any portion of the
10 Estate of said decedent is in any contingency capable of being
11 held in Trust for a longer period than is permitted by the law of
12 the state of the domicile of said FERDINAND HECHINGER, or if in
13 any such contingency the vesting of any interest under his said
14 Will may occur after the expiration of such permissive period,
15 then upon the happening of any such contingency, such portion of
16 the Estate of said decedent shall not be held in further Trust,
17 but shall rather be paid over absolutely to the person or persons
18 to whom, and in the proportions in which the income therefrom was
19 payable.

20 Upon any division or partial or final distribution of
21 the property of the Trust Estate, as herein provided, the Trustee
22 may divide or distribute such property in kind, including un-
23 divided interests therein, or in his absolute discretion the
24 Trustee may sell all or any part of such property and make such
25 division or distribution in cash or partly in cash and partly in
26 kind, and the decision of the Trustee as to what constitutes a
27 proper division of the Trust Estate either prior to or upon any
28 distribution thereof shall be binding upon all of the beneficiar-
29 ies.

30 The Trustee is authorized to retain in the Trust, for
31 such time as he may deem advisable, any property received by him
32 hereunder, whether or not of the character permitted by law for

1 the investment of Trust funds; and to continue and operate any
2 business which he may receive hereunder; so long as in his ab-
3 solute discretion the Trustee may deem it advisable to do so,
4 the Trustee shall have the power, with respect to the
5 property of the Trust Estate or any part hereof, and upon such
6 terms and in such manner as he may deem advisable, to sell, con-
7 vey, exchange, convert, improve, repair, manage, operate and con-
8 trol; to lease for terms within or beyond the term of this Trust
9 and for any purpose, including exploration for and removal of gas,
10 oil and other minerals; to borrow money for any Trust purpose, and
11 to encumber or hypothecate by mortgage, deed of trust, pledge or
12 otherwise; to carry insurance of such kinds and in such amounts
13 as the Trustee may deem advisable at the expense of the Trust;
14 to compromise or otherwise adjust any claims against or in favor
15 of the Trust; to commence or defend such litigation with respect
16 to the Trust or any property of the Trust Estate as he may deem
17 advisable, at the expense of the Trust; to invest and reinvest
18 the Trust funds in such property as the Trustee may deem advis-
19 able, whether or not of the character permitted by law for the
20 investment of Trust funds, and with respect to securities held
21 in the Trust, to vote, give proxies and pay assessments or other
22 charges, to participate in foreclosures, reorganizations, con-
23 solidations, mergers and liquidations, and incident thereto to
24 deposit securities with and transfer title to any protective or
25 other committee upon such terms as the Trustee may deem advisable,
26 and to exercise or sell stock subscription or conversion rights,
27 and the Trustee shall have such additional powers as may now or
28 hereafter be conferred upon him by law or as may be necessary to
29 enable the Trustee to administer this Trust in accordance with
30 the provisions of said Will of said decedent, subject to any
31 limitations thereof that may be provided for in said Will.

32 The Trustee, in the Trustee's discretion, may make pay-

ments directly to a minor if in the Trustee's judgment the minor is of sufficient age and maturity to spend the money properly.

There need be no physical segregation or division of the various Trusts except as segregation or division may be required by the termination of any of the Trusts, but the Trustee shall keep separate accounts for the different undivided interests.

ALBERT R. HECHINGER, in his capacity as Trustee under said Will of said decedent, need not provide bond.
