SUPPLEMENTAL AGREEMENT NO. 1, made and entered into this 15th day
of September, 1972, by and between Southern Pacific Land Company,
hereinafter called the Lessor, and the United States of America, hereinafter
called the Government.

W I T N E S S E T H

WHEREAS, by Lease, dated 20 September 1971, bearing Government Contract Number
DOT-FA71WE-1242, by and between the parties hereto, the Government is authorized
to occupy approximately 0.43 acres, more or less, in the County of Eureka,
State of Nevada, utilized for our RML site and road right-of-way, such land
being more specifically described in the aforesaid Lease; and

WHEREAS, the Lessor desires to reinstate deleted Article 15; and

WHEREAS, the Government is agreeable to such reinstatement deleting a portion
of the present verbage:

NOW THEREFORE, effective September 15, 1972, the parties do hereby
amend said Lease in the following respects and these only:

1. Article 15 is hereby added hereto and is made a part hereof.

The Government agrees to cooperate with representatives or agents
of said Southern Pacific Transportation Company to determine the
cause of any interference with said communication facilities *

ALL OTHER TERMS AND CONDITIONS of the Lease are hereby ratified and, except
as amended hereinabove, shall be and remain the same.

*and, if found to be caused by Government's equipment,
to promptly correct same.
