2 unto the Party of the Second Part, her heirs and assigns forever.

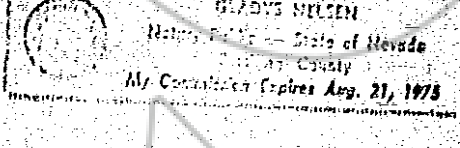


