15 COMES NOW, BANK OF NEVADA, a Nevada Banking Corporation,
16 as Administrator With the Will Annexed of the Estate of FERDINAND
17 HECHINGER, deceased, acting by and through its attorney, JOHN
18 PETER LEE, ESQ. of the firm of LEE AND BEASEY, and proves to the
19 satisfaction of the Court that its First and Final Account, Report
20 and Petition for Distribution and Discharge of Administrator With
21 the Will Annexed was rendered and filed herein on the 16th day of
22 October, 1972; that on the 16th day of October, 1972 the Court
23 appointed Friday the 10th day of November, 1972 at the hour of
24 9:15 o'clock A.M. of said day for the settlement and hearing
25 thereof, and due and legal notice of the time and place of said
26 settlement and hearing has been given, as required by law, as is
27 shown by the Affidavit of Posting and Affidavit of Publication on
28 file herein, that on the 10th day of November, 1972 hearing of

2 account and report and orders distribution of said estate as

4 IT IS FOUND BY the Court that due notice to the
5 creditors of said deceased has been given as required by law,
6 that due notice of the time and place of the settlement of said
7 Account and Report and Petition for Distribution has been given
8 as required by law, and proof of all of the foregoing has been

26 PETER LEE, ESQ. be, and he is hereby awarded the sum of \$1,127.25
27 as attorney's fees, which is hereby fixed as a reasonable attor-
28 ney's fee for his services rendered in this matter.
