## LOCATION CERTIFICATE

THIS IS TO CERTIFY that the BOTCHY No. 4  
lode mining claim was located by James I. Barnes, whose present  
address is 4365 Canyon Drive, Reno, Nevada 89503, on the  
first day of December, 1972.

The general course of the vein or lode is northeast and  
southwest. The claim is situated in unorganized  
Mining District, Eureka County, Nevada. The discovery  
monument is located approximately 810 feet from the  
northeast corner of Section 4, Township 21 N, Range 50 E,  
as shown on the map filed herewith. The undersigned claims  
1470 feet in a northeasterly direction, and 30 feet  
in a southwesterly direction from the point of discovery, with a  
width of 300 feet on each side of the middle of the vein or lode.

This is one of a group of 36 contiguous claims. The dis-  
covery work for the benefit of the entire group consisted of:

Geochemical survey of entire claim group; rock chip  
sampling program. Hand excavation at selected points.

The corners and side centers of the claim are located and  
marked as follows:

BEGINNING at the west corner a 4-inch by 4-inch by 4 1/2  
foot wooden post set in a mound of earth and stones 2 feet in height by  
4 feet in diameter and marked "W Cor. Botchy No. 4"; thence NE  
750 feet to the NW side center post, a post of the same dimensions  
surrounded by a mound of earth and stones as described above and marked  
"NW Side Center Botchy No. 4"; thence NE 750 feet to the  
north corner, a post of the same dimensions surrounded by earth and stones  
and marked "N Cor. Botchy No. 4"; thence SE 600 feet to  
the east corner, a post of the same dimensions surrounded by earth and  
stones as set forth above and marked "E Cor. Botchy No. 4"; thence  
SW 750 feet to the SE side center post, a post of the same  
dimensions surrounded by earth and stones as set forth above and marked  
"SE Side Center Botchy No. 4"; thence 750 feet to the south corner  
of the claim, a post of the same dimensions surrounded by earth and stones as  
set forth above and marked "S Cor. Botchy No. 4"; thence 600 feet NW  
to the point of beginning.
