

SUBORDINATION AGREEMENT

WHEREAS, LIBERTY LIVESTOCK, a co-partnership, consisting of J. H. SEWELL and MOLLIE S. SEWELL, his wife, and THOMAS H. GALLAGHER and DOROTHY S. GALLAGHER, his wife, are Grantors in that certain Deed of Trust dated January 2, 1973, wherein FIRST AMERICAN TITLE COMPANY OF NEVADA, a Nevada Corporation, is Trustee, and CHARLES DAMELE, also known as CHARLES J. DAMELE and JUANITA DAMELE, his wife, are beneficiaries, which said Deed of Trust is recorded in Book 44 of Official Records, Page 337, in the Office of the County Recorder of Elko County, Nevada; and

WHEREAS, the Beneficiaries, above named, CHARLES J. DAMELE and JUANITA DAMELE, his wife, have agreed to subordinate their said Deed of Trust to a first mortgage or Deed of Trust to the TRAVELERS INSURANCE COMPANY on the said real property, provided that said first mortgage or Deed of Trust does not secure a loan exceeding ONE MILLION (\$1,000,000.00) DOLLARS.

NOW, THEREFORE, the undersigned CHARLES J. DAMELE and JUANITA DAMELE, his wife, pursuant to their agreement, as above set forth, do hereby agree that the lien of their said Deed of Trust shall be subordinated to, and made subject to, the lien of that certain Deed of Trust dated December 12, 1972, in favor of the TRAVELERS INSURANCE COMPANY; said subordination to be limited to a loan wherein the principal sum is not to exceed ONE MILLION (\$1,000,000.00) DOLLARS.
