Deed

(BY CORPORATION)

THIS INDENTURE, made and entered into this 7th day of May, 1973, by and between FIRST AMERICAN TITLE COMPANY OF NEVADA, formerly known as NEVADA TITLE GUARANTY COMPANY, a Nevada corporation, party of the first part, and JAMES McISAAC and NORMA McISAAC, husband and wife as joint tenants with right of survivorship, whose address is % Charles W. WITNESSETH:

That the said party of the first part, in consideration of the sum of TEN DOLLARS (\$10.00), lawful money of the United States of America, to it in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain and sell unto the said parties of the second part, and to the survivor of them, and to the heirs and assigns of such survivor forever, an undivided one-third (1/3) interest in that certain real property situate in the County of Eureka, State of Nevada that is described as follows:

Section 19: All, consisting of Lots 1, 2, 3 and 4.

RESERVING, THEREFROM, an easement of 30' along all boundaries for ingress and egress, with power to dedicate, and, except any and all oil rights, including the right of entry for exploration and production of oil or other carbohydrates.
