RIGHT-OF-WAY GRANT AND EASEMENT

 THIS AGREEMENT AND GRANT, made <sup>as of</sup> this 21st day of September, 1972, by and between EAST UTAH MINING COMPANY, a Utah corporation, hereinafter referred to as "Grantor", and CARLIN GOLD MINING COMPANY, a Delaware corporation, hereinafter referred to as "Grantee";

WHEREAS, Grantor is the owner of certain unpatented mining claims located in Section 13, Township 36 North, Range 49 East, M.D.B.&M.; and

WHEREAS, Grantee is engaged in mining and milling operations centered in Section 14, Township 35 North, Range 50 East, M.D.B.&M., and has located thereon a milling plant; and

WHEREAS, Grantee is desirous of constructing a road for the purpose of ingress and egress to and from certain patented and unpatented mining claims owned by Grantee in Sections 2, 3, 10 and 11, Township 36 North, Range 49 East, M.D.B.&M., and for the purpose of exploring, extracting, hauling and transporting minerals and other substances from said claims to Grantee's millsite, and to acquire from Grantor a right-of-way and easement for the construction and maintenance of said road; and

WHEREAS, Grantor is willing to convey to Grantee an easement to construct, use and maintain said road, all as hereinafter set forth;

NOW, THEREFORE, for and in consideration of the sum of TEN DOLLARS (\$10.00) lawful money of the United States, to Grantor in hand paid by Grantee, and in consideration of the covenants hereinafter contained, Grantor does hereby give and grant to Grantee a right-of-way and easement for the construction and maintenance of a road across and affecting the mining claims of Grantor in Section 13, Township 36 North, Range 49 East, M.D.B.&M., which right-of-way and easement shall be:

A fifty-foot (50') right-of-way beginning at a point 1,320 feet east of the S. E. Corner of Section 13, Township 36 North, Range 49 East, M.D.B.&M., and proceeding in Westerly and Northwesterly directions to the point of ending at a point 1,450 feet N. 65°30' West of the S. E. Corner of Section 13.

As is more fully described on the map attached hereto as Exhibit "A" and incorporated by reference.

The rights and easements hereinbefore granted shall remain in effect so long as Grantee carries on its mining or milling operations in Section 14, Township 35 North, Range 50 East, M.D.B.&M., and mining or exploratory activities appurtenant thereto.

IT IS FURTHER AGREED between Grantor and Grantee as follows:

1. That any road built by Grantee on the easement and right-of-way herein granted shall be at the expense of Grantee.

2. That the road constructed over said easement and right-of-way shall be at least thirty (30) feet wide with proper turn-outs provided and be of a rock base where needed with proper drainage and culverts provided.

3. That if in the future it becomes necessary to remove the road constructed under this right-of-way and easement so that Grantor can remove ore from the claims over which the road traverses, the route of said road will be changed by Grantee to a different place at its own expense.

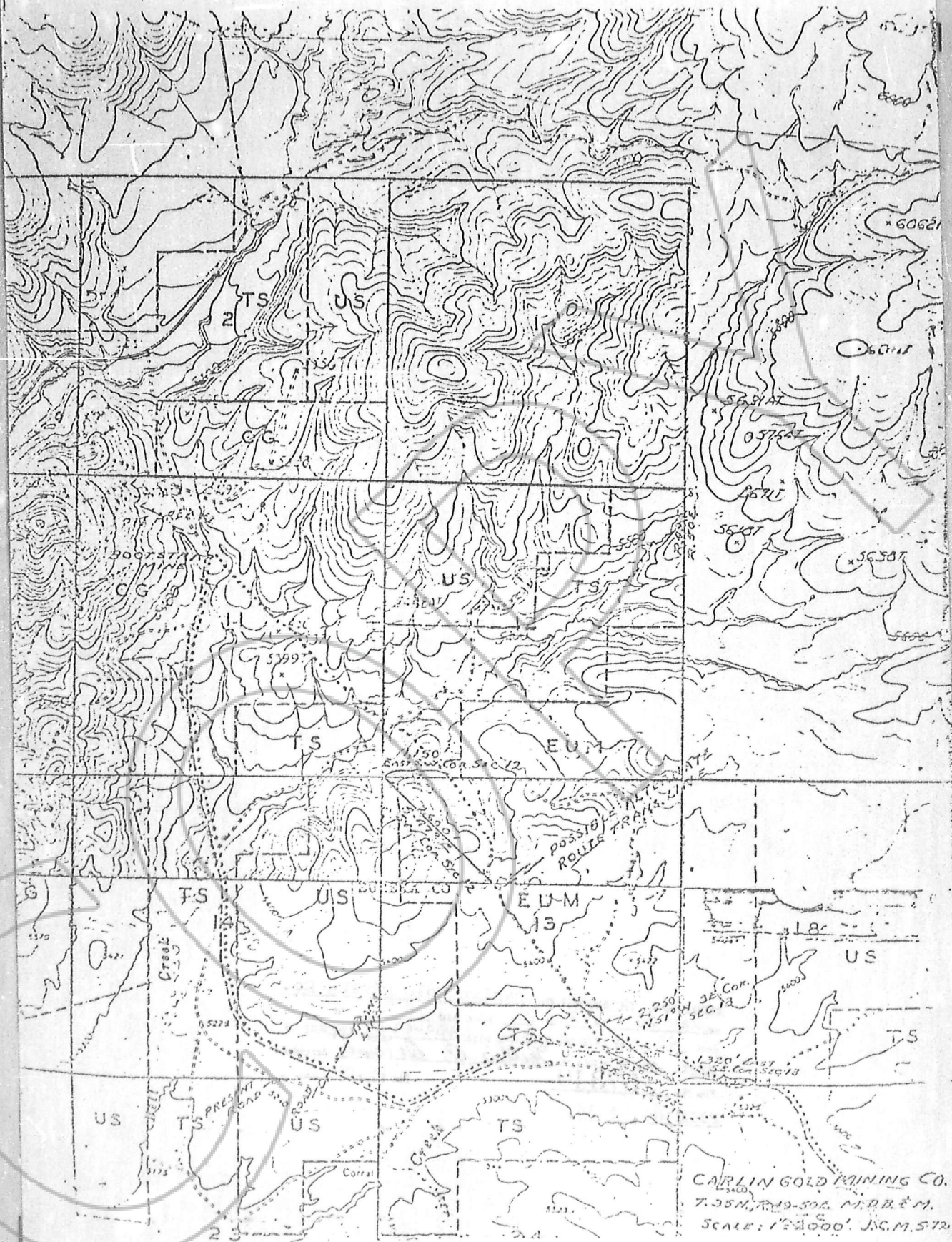
