

Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the MARYNELL # 3 Lode Mining Claim was located by DYESS & SHUPE'S, whose post office address appears below, on the 28 day of JUNE, 1973.

WEST corner, a monument marked S.W. # 3 Cor., thence 600 feet in a EASTERLY direction to the S.E. corner, a monument marked SE # 4 Cor., thence 750 feet in a NORTHERLY direction to the EAST side center, a monument marked EAST SC, thence 750 feet NORTHERLY to the point of beginning.

Each of the above-described monuments is A TRIMMED CEDAR OR PINE TREE
