NOTICE IS HEREBY GIVEN that East Utah Mining Company, a Utah corporation, has caused work to be done and/or improvements made as follows on the following-named unpatented lode mining claims situated in the Lynn Mining District, Eureka County, State of Nevada:

Chicago No. 2 Chicago No. 4 Chicago No. 8
Chicago No. 3 Chicago No. 7 Chicago No. 9

The work consisted of a detailed geologic mapping survey within the outside boundaries of said contiguous blocks and individual claims as well as outside the boundaries so that geologic continuity of mapped features could be maintained.

Work was performed by and/or under the direction of:

Detailed geologic mapping was done directly on a controlled topographic map prepared at a scale of 1"=200', with 10' contour intervals and supplemental intervals at 5'. Low level colored photographs at an original contact scale of 1"=300' (40% overlap), enlarged to 1"=200' using the central 60% to eliminate edge and distortion, were utilized for mapping correlation with actual field observations. Basic findings of the survey are depicted on a geologic map, copy of which is attached hereto and marked Exhibit I. The purpose of the survey was to map in detail the rock types present in relation to major shear zones defined by geophysical methods, as well as to define mineral trends and alteration phenomena present and was non-repetitive of any past geologic survey.

Said work was performed and improvements made at the request of the owner, East Utah Mining Company, and had a value in excess of One Hundred (\$100.00) Dollars for each claim.

The undersigned is the President and General Manager of said East Utah Mining Company and is the person who directed the performance of such labor and improvements.

Said labor was performed and improvements made between 12:00 o'clock meridian on September 1, 1972 and 12:00 o'clock meridian on September 1, 1973.
