## EXTENSION AGREEMENT

THIS AGREEMENT made and entered into this 20th day of July-1973, by and between Dominick G:-Stocketti, Myrtle Marie Stocketti, Robert L. Stocketti, Beverly Stocketti, John Stocketti, and Shirley Stocketti, hereinafter called Lesson, and American Thermal Resources, Inc., a Nevada corporation, hereinafter called Lessee.

## WITNESSETH
