EXTENSION AGREEMENT

THIS AGREEMENT made and entered into this 20th day of July 1973, by and between Lloyd Harris and Marla J. Harris, hereinafter called Lessor, and American Thormal Resources, Inc., a Nevada corporation, hereinafter called Lessee:
