EXTENSION AGREEMENT

THIS AGREEMENT made and entered into this 24th day of July, 1973 by and between Lloyd Saladino and Gertrude Saladino, hereinafter called Lessor, and American Thermal Resources, Inc., a Nevada corporation, hereinafter called Lessee.
