one-half interest, in joint tenancy with right of survivorship;
their assigns and the heirs and assigns of the survivor forever,
the following described real property situated in Eureka County,
Nevada, and more particularly described as follows, to-wit:

The Southwest Quarter of the Southeast
Quarter, South Half of the Southwest
Quarter of Section Seventeen (17),
Northwest Quarter of Section Twenty (20),

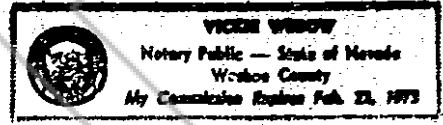
