Please take notice that W. L. Wilson, being first duly sworn, says that in excess of \$2,100.00, being more than \$100.00 per unpatented mining claim (identified below), was expended for labor and improvements on or with respect to such claims, consisting of a geological survey of the claims, consisting of a correlation and compilation of previous geological and geochemical work, additional geologic mapping, and geochemical sampling, all directed at a geological-geochemical survey of the claims to formulate a drilling program for future work. This work was non-repetitive of previous work done on the claims. Attached as Exhibit "A" is a report of the basic findings of Mr. Carithers' work.

STATEMENT OF GEOLOGIC INVESTIGATIONS FOR THE BENEFIT OF THE DOE, REY, ME, TONKIN
AND IMPERIAL GROUP OF 21 LODE MINING CLAIMS, TONKIN DISTRICT, EUREKA COUNTY,
NEVADA:

With respect to the Annual Labor performed on and for the benefit of the subject mining claims during the Assessment year ending September 1, 1973, this is to certify that the writer, Ward Carithers, conducted a geological investigation of the said mining property during the month of August, 1973. Said investigative work was done at the instance of and expense of Idaho Mining Corporation as directed by W. L. Wilson, President.

The basic findings of the investigation are:

- (1) The rocks of the claim area consist of a sequence of limestone, shale and chert of Paleozoic age overlain unconformably by rhyolitic tuff and dacitic flows of Tertiary age. These rocks are considerably obscured by alluvium.
- (2) The Paleozoic and Tertiary rocks are displaced by a fault-breccia zone that trends northward through the claim area. Mineralization by minor amounts of barite, calcite, pyrite, antimony, mercury, silver and gold is associated with the fault zone.
