W I T N E S S E T H:

That the said parties of the first part, for and in consideration of the sum of One Dollar (\$1.00), lawful money of the United States of America, and other good and valuable considerations, the receipt whereof is hereby acknowledged, do hereby grant, bargain and sell unto the said parties of the second part, in joint tenancy and to the survivor of them and to the heirs of such survivor forever, all those certain lots, pieces or parcels of land situate, lying and being in the County of Eureka, State of Nevada, and bounded and particularly described as follows, to-wit:

All of Lots 7 and 8 in Block No. 5, together with the improvements thereon; also, all of the south 12 (twelve) inches of Lot 6, in Block 5, as the same adjoins Lot 7, in Block 5, which said twelve (12) inches was previously conveyed to Edward Thayer by G. B. Biale.
