

CERTIFICATE OF RELOCATION OF LODE CLAIM

THIS IS TO CERTIFY that the Quartz Hills 50 lode mining claim (previously abandoned) was relocated by IDAHO MINING CORPORATION on the 5th day of September, 1973. The locator adopted the monuments and boundaries of the original claim, renewing any monuments that were down or absent, and remarking with metal tags the previous corner posts.

This claim is situate in T. 23½ N., R. 50 E. (unsurveyed), in one or more of the following sections: One (1) & Two (2). The Northwest corner of this claim is situated at a point from which the claim location marker bears Northwest 3185 feet, North 7° West
