Said work was performed on the Antimony Dick, Gold Queen No. 1, June, and Boulder Cap No. 7 claims.

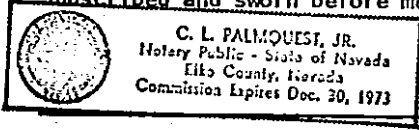
