EXTENSION AGREEMENT

THIS AGREEMENT made and entered into this 27th day of November 1973, by and between Dominick G. Stoccketti, Myrtle Marie Stoccketti, Robert L. Stoccketti, Beverly Stoccketti, John Stoccketti, and Shirley Stoccketti, hereinafter called Lessor, and American Thermal Resources, Inc., a Nevada corporation, hereinafter called Lessee.

WITNESSETH

WHEREAS, on February 1, 1972, Lessee and Lessor entered into a Geothermal Lease and Agreement covering the following described lands situated in Lander and Eureka Counties, Nevada:

TOWNSHIP 31 NORTH, RANGE 48 EAST, M.D.B. & M.

Section 5: W/2 SW/4
Section 7: SE/4 SE/4

which said lease was made for a primary term of fifteen (15) months, commencing ninety (90) days after the date of said lease, and as long thereafter as geothermal resources are produced from said premises, and

WHEREAS, on July 20, 1973, Lessor and Lessee entered into an Extension Agreement whereby the primary term was extended until August 1, 1974 and

WHEREAS, Lessor and Lessee now desire to extend the primary term until August 1, 1978,

NOW THEREFORE, in consideration of the premises, the payment of Ten Dollars (\$10.00) by Lessee to Lessor, of lease rental to be paid by Lessee to Lessor, and other good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged, and for the purpose of extending the primary term of said lease, it is hereby agreed that the primary term of said lease is hereby extended until August 1, 1978.

Lessor acknowledges that said lease, as extended is valid and in full force and effect and for such purpose Lessor hereby grants, leases, lets, and demises to Lessee all of Lessor's interest in the above described lands upon the same terms, conditions, and provisions as are contained in said lease as amended hereby.

This agreement shall be binding upon and inure to the benefit of the parties hereto, their heirs, successors, personal representatives and assigns.

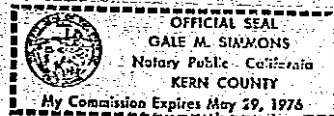
