17 1. That SUSIE STRICKLAND died in Brigham City, Utah,  
18 on the 13th day of September, 1973, and at the time of her death  
19 was a resident of said City and State.

20 2. That said Decedent died Intestate.

21 3. That said Decedent died leaving no surviving spouse;

25 that said Attorneys be reimbursed the sum of \$19.00 costs ad-  
vanced on behalf of said Estate.

26 3. That Petitioner, having waived the right to the  
27 payment of fees and services performed for said estate, none are  
28 hereby allowed by the Court.
