GRANT, BARGAIN AND SALE DEED

THIS INDENTURE, made and entered into this 21<sup>st</sup> day of February, 1974, by and between HAWKHYE'S PONTIAC, BUICK, CADILLAC, GMC, a Nevada Corporation, of the City of Elko, County of Elko, State of Nevada, First Party; and STEVEN E. W I T N E S S E T H:
