

**AFFIDAVIT OF PERFORMANCE OF
ANNUAL WORK AND IMPROVEMENTS**

BEN F. DICKERSON III, being first duly sworn, deposes and says:

That he is the Manager, Minerals Division, in charge of operations on the hereinafter described unpatented lode mining claims for THE SUPERIOR OIL COMPANY;

That he is familiar with those certain unpatented lode mining claims situated in the Buckhorn Mining District, Eureka County, Nevada, more particularly described in Exhibit A attached hereto and made a part hereof;

That between the period beginning December 13, 1973, and ending February 5, 1974, at least ONE HUNDRED DOLLARS (\$100.00) worth of work and labor was performed on or for the benefit of each of the said unpatented lode mining claims by and on behalf of the owners thereof for the assessment year beginning on September 1, 1973, and ending on September 1, 1974, at expense and in a value in excess of SIXTEEN-THOUSAND SEVEN HUNDRED DOLLARS (\$16,700.00).

That all of the unpatented lode mining claims are contiguous and that the work was performed under a common plan of development for all of the said claims, which claims are owned by The Superior Oil Company and that the work was performed by and on behalf of The Superior Oil Company; that the work consisted of a systematic drilling program whereunder a series of rotary drill holes having an aggregate of not less than 2,540 feet were drilled at numerous sites on said claims for the purpose

of evaluating all of the said claims and that in addition to the drilling program, work consisting of preparation of drill sites, construction of access roads and sampling was conducted, including work performed on the following claims:
