REVOCATION OF POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

That whereas, I, the Roman Catholic Bishop of Reno, a Corporation Sole, M. Joseph Green, Incumbent, in my power of attorney, in writing, bearing date the sixteenth day of July, 1968, make, constitute and appoint Reverend Maurice L. Welsh, Chancellor of the Diocese of Reno; Right Reverend Thomas Collins, Vicar-General of the Diocese of Reno; and Reverend Charles J. Righini, Vicar-General of the Diocese of Reno, my true and lawful attorney, for the purposes and with the powers therein set forth, or to the record thereof, made on the said sixteenth day of July, 1968, in Book 331 page 771, in the Office of the County Recorder of the said County of Washoe.

Now, therefore, I, the Roman Catholic Bishop of Reno, a Corporation Sole, M. Joseph Green, Incumbent have revoked, countermanded, annulled and made void, and by these presents do revoke, countermand, annul and make void, the said power of attorney, and all power and authority thereby given, or intended to be given, to the said Reverend Maurice Welsh, Right Reverend Thomas F. Collins, and Reverend Charles J. Righini.

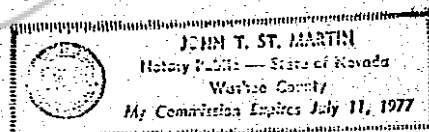
