 6 as joint tenants and not tenants in common, herein called Bene-
 7 ficiaries,

8 WITNESSETH: That Trustors irrevocably grant, transfer and
 9 assign to Trustee in trust, with power of sale, that property in
 10 Eureka County, Nevada, described as:

11 Lots 5 and 6, E. 1/2 of NW 1/4, NE 1/4
 12 of Section 7, Township 21 N. Range 53
 E., M.D.B.&M.

13 TOGETHER WITH the rents, issues and profits thereof, reserving
 14 the right to collect and use the same except during continuance of
 15 some default hereunder and during continuance of such default
 16 authorizing Beneficiaries to collect and enforce the same by any
 17 lawful means in the name of any party hereto.

18 For the purpose of securing: 1. Performance of each agree-
 19 ment of Trustors incorporated by reference or contained herein.
 20 2. Payment of the indebtedness evidenced by one promissory note
 21 of even date herewith, and any extension or renewal thereof, in
 22 the principal sum of \$77,000 executed by Trustors in favor of
 23 Beneficiaries or order. 3. Payment of such additional sums as
 24 may hereafter be advanced for the account of Trustors or Assigns
 25 by Beneficiaries with interest thereon.

26 To protect the security of this Deed of Trust, Trustors agree:
 27 By the execution and delivery of this Deed of Trust and the note
 28 secured hereby, that provisions (1) to (16) inclusive of the Deed
 29 of Trust recorded in the Book and at the page, or document No. of
 30 Official Records in the Office of the county recorder of Eureka
 31 County where said property is located, viz: Document No. 39602,
 32 Book 3, page 283 (which provisions, are attached hereto as Exhibit
 A) hereby are adopted and incorporated herein and made a part

1 hereof as fully as though set forth herein at length; that they
2 will observe and perform said provisions; and that the references
3 to property, obligations, and parties in said provisions shall be

7 of fire insurance required by covenant 2 shall be \$11,000.00
8 and with respect to attorney's fees provided for by covenant 7 the
9 percentage shall be 10%.

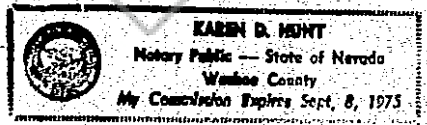
