

QUITCLAIM DEED

W I T N E S S E T H:

That the said First Parties, for and in consideration of the sum of TEN DOLLARS (\$10.00), lawful money of the United States of America, to them in hand paid by the said Second Parties, and other good and valuable consideration, receipt whereof is hereby acknowledged, do by these presents remise, release and forever quitclaim unto the Second Parties, as joint tenants with right of survivorship and not as tenants in common, and to the assigns of said Second Parties, and to the survivor of them, and to the heirs, executors, administrators and assigns of the survivor forever, all right, title and interest which they may have in and to that certain real property situate, lying and being in the County of Eureka, State of Nevada, more particularly described as follows:

Lots 1, 2, 3 and 4 in Block 90, and Lot 1 in Block 102, Town of Eureka, as shown on the plat filed in the office of the County Recorder of Eureka County, Nevada.

TOGETHER WITH all buildings and improvements situate thereon.

TOGETHER WITH the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

EXCEPTING AND RESERVING all uranium, thorium, or any other material which is or may be determined to be peculiarly essential to the production of fissionable materials, as reserved by the United States of America in Patent dated December 1, 1947, and recorded December 19, 1947, in Book 23 of Deeds at page 226, Eureka County, Nevada.

TO HAVE AND TO HOLD the said premises, together with the appurtenances unto the said Second Parties as joint tenants with right of survivorship and not as tenants in common, and to their assigns, and to the survivor of them, and to the heirs, executors, administrators and assigns of the survivor forever.

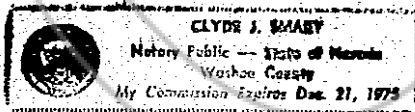

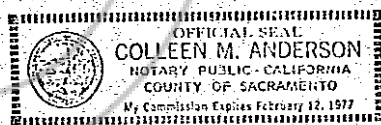
