CERTIFICATE OF LOCATION
LODE

THIS IS TO CERTIFY That the ERV 13 lode mining claim was located on the 7th day of December, 1971, situated in the Diamond Mining District, County of Eureka, State of Nevada, and about 28 & 27 R. 54 E., T. 21 N., Section 33 & 34. (See map filed: Eagle Roost Venture Group, Map No. ERV - 1).

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 25 feet from the location monument in a southerly direction, and 1475 feet from the location monument in a northerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim
