LOCATION CERTIFICATE

KNOW ALL MEN BY THESE PRESENTS, That CARL L. BURLEY, of Grand Junction, Colorado has located the Sue #11 lode mining claim, and by this certificate, and by right of discovery and location, claims 1500 feet, linear and horizontal measurement along the vein thereof, with all its dips, angles, and variations as allowed by law 1490 feet on said vein running SW from the center of the Discovery Monument and 10 feet running NE from the center of the Discovery Monument together with 300 feet on each side of the middle of said vein at the surface, and all veins, lodes, ledges, deposits and surface ground within the lines of said claim, situated in Unknown Mining District, County of Eureka, State of Nevada and described by metes and bounds as follows, to wit:

Beginning at the NW Corner lying 12,718 feet South and 4566 feet East from the SE Corner Section 36 Township 23, North, Range 51 East, thence 750 feet NE to the North Side Center, thence 750 feet NE to the NE Corner, thence 600 feet SE to the SE Corner, thence 750 feet SW to the South Side Center, thence 750 feet SW to the SW Corner, thence 600 feet NW, to the point of beginning.

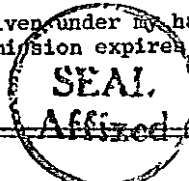
