

LOCATION CERTIFICATE

KNOW ALL MEN BY THESE PRESENTS, That CARL L. 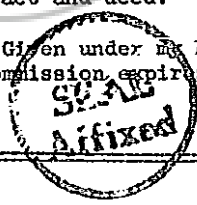
