

KNOW ALL MEN BY THESE PRESENTS, That CARL L. BURLEY, of Grand Junction, Colorado has located the Sue #176 lode mining claim, and by this certificate, and by right of discovery and location, claims 1500 feet, linear and horizontal measurement along the vein thereof, with all its dips, angles, and variations as allowed by law 1490 feet on said vein running NE from the center of the Discovery Monument and 10 feet running SW from the center of the Discovery Monument together with 300 feet on each side of the middle of said vein at the surface, and all veins, lodes, ledges, deposits and surface ground within the lines of said claim, situated in Unknown Mining District, County of Eureka, State of Nevada and described by metes and bounds as follows, to wit:

ALL OF THE CORNERS AND MONUMENTS HEREIN DESCRIBED CONSIST OF WOOD POSTS AT LEAST 4" IN DIAMETER AND 4½' IN LENGTH SET 1 FOOT IN THE GROUND ON WHICH IS POSTED AN ALUMINIZED TAG MARKED SO AS TO DESIGNATE THE PART OF THE CLAIM ON WHICH IT IS LOCATED.

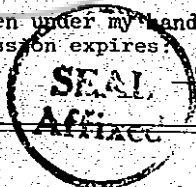
