W I T N E S S E T H:

That the party of the first part, for and in consideration

of America, to her in hand paid by the parties of the second part,
the receipt of which is hereby acknowledged, does by these presents
grant, bargain, and sell unto the parties of the second part, as
joint tenants with right of survivorship and not as tenants in
common, and to the survivor of them, and their assigns, and to the
heirs, executors, administrators, and assigns of the survivor,
forever, all that certain property situate in the County of Eureka,
State of Nevada, more particularly described as follows:

Two certain mining claims situate in what is known as

in the northerly end of Eureka County, State of Nevada,

of the survivor, forever.

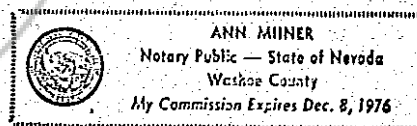
