

LOCATION CERTIFICATE

KNOW ALL MEN BY THESE PRESENTS, That CARL L. BURLEY, of Grand Junction, Colorado has located the Sue # 79 lode mining claim, and by this certificate, and by right of discovery and location, claims 1500 feet, linear and horizontal measurement along the vein thereof, with all its dips, angles, and variations as allowed by law 1490 feet on said vein running SW from the center of the Discovery Monument and 10 feet running NE from the center of the Discovery Monument together with 300 feet on each side of the middle of said vein at the surface, and all veins, lodes, ledges, deposits and surface ground within the lines of said claim, situated in Mt Hope Mining District, County of Eureka, State of Nevada and described by metes and bounds as follows, to wit:
