

INDENTURE

THIS INDENTURE, made this 21 day of August, 1974,  
between CARL L. BURLEY and LOUISE BURLEY, husband and wife, of Grand  
Junction, Colorado, the Grantor (whether one or more) and GULF OIL  
CORPORATION, a Pennsylvania corporation, having an office at 1780 South  
Bellaire Street, Denver, Colorado, the Grantee:

## W I T N E S S E T H:

That the Grantor, for and in consideration of the sum of Ten  
Dollars (\$10.00) and other good and valuable consideration, the receipt  
of which is acknowledged, does by these presents grant, bargain, sell and  
convey unto the Grantee all those certain mining claims situate in the  
County of Eureka, State of Nevada and described in Certificates of Location  
thereof which are recorded in the Office of the Recorder of Eureka County,  
said mining claims and the recording of information pertaining to the Certi-  
ficates of Location thereof being more fully described in Exhibit "A" which  
is attached hereto and made a part hereof.

Together with all and singular the mines, minerals, veins, lodes,  
ledges, deposits, rock and earth within the lines of said claim, their  
dips, spurs, angles, and extralateral rights, and all dumps, severed ore,  
fixtures, improvements, rights privileges and franchises thereto incident,  
appendant and appurtenant, or therewith usually had and enjoyed; and also  
all and singular the tenements, hereditaments and appurtenances thereto  
belonging, or in anywise appertaining, and the rents, issues and profits  
thereof.

To have and to hold, all and singular, the premises, together  
with the appurtenances and privileges thereto incident, unto Grantee, its  
successors and assigns forever.

The Grantor hereby covenants for himself, his heirs and assigns  
that the above described premises are free and clear of all liens and  
encumbrances; that the described claims were located in accordance with  
the applicable provisions of the United States of America and Nevada law

and have been maintained against relocation by the requisite amounts of annual assessment work; and that he will warrant and defend the title especially against all parties claiming by, through or under him.
