DIABLO MERIDIAN, EUREKA COUNTY, STATE OF NEVADA.

Jack M. Ahearn, a Registered Engineer and Land Surveyor of the State of Utah reports that the assessment work for the assessment year ending Sept. 1, 1974 was performed and made for the foregoing Lode Mining Claims, situated in Sec. 18, Twp. 35 N., R. 51 E., MDM., Eureka County, Nevada.

That during the assessment year ending Sept. 1, 1974 at least \$1100.00 worth of labor was performed and made on, or for, the benefit of, the contiguous Lode Mining Claims included in the aforementioned group. That such labor and improvements consisted of the assaying of material from shallow drill holes arranged and located in accordance with the following description: Beginning at a point, designated as sample station No. 1 that bears S.13°10'W. at a distance of 2710 ft. m or l from the brass cap marking the E. 1/4 corner of Sec. 18, T.35N., R.51 E., Eureka County, Nevada; thence N.61°20'W. a distance of 2700 ft. to sample station No. 28; thence S.28°30'W. a distance of 200 ft. m or l; thence S.61°21'E. a distance of 100 ft. m or l to sample station No. 29; thence S.61°20'E. a distance of 2200 ft. m or l to sample station No. 51; thence S.28°30'W. a distance of 200 ft. m or l; thence N.61°20'W. a distance of 300 ft. m or l to sample station No. 52; thence N.61°20'W. a distance of 1800 ft. m or l to sample station No. 70; thence S.28°30'W. a distance of 200 ft. m or l; thence S.61°20'E. a distance of 100 ft. m or l to sample station No. 71; thence S.61°20'E. a distance of 1300 ft. m or l to sample station No. 84; thence S.28°30'W. a distance of 200 ft. m or l; thence N.61°20'W. a distance of 300 ft. m or l to sample station No. 85; thence N.61°20'W. a distance of 900 ft. m or l to sample station No. 94 which is the terminus of the sample line heretofore described. The positioning of the above described sample pattern was predicated on field and photogrammetric determination of the juxtaposition of a fault and a contact zone of Ordovician age.

All of the above work was done at the request of, and on behalf of, Robert B. Mee a resident of Salt Lake County, State of Utah whose mailing address is Box 11117, Salt Lake City, Utah, 84111.

That said work was performed and expenditures made for the purpose of complying with the laws of the United States and of the State of Nevada pertaining to Annual Assessment Work. All of said claims are contiguous and all work was performed as part of a common over-all program for the mutual and individual benefit of said claims. Said work was done, and expenditures made, during the months of June and August, 1974.

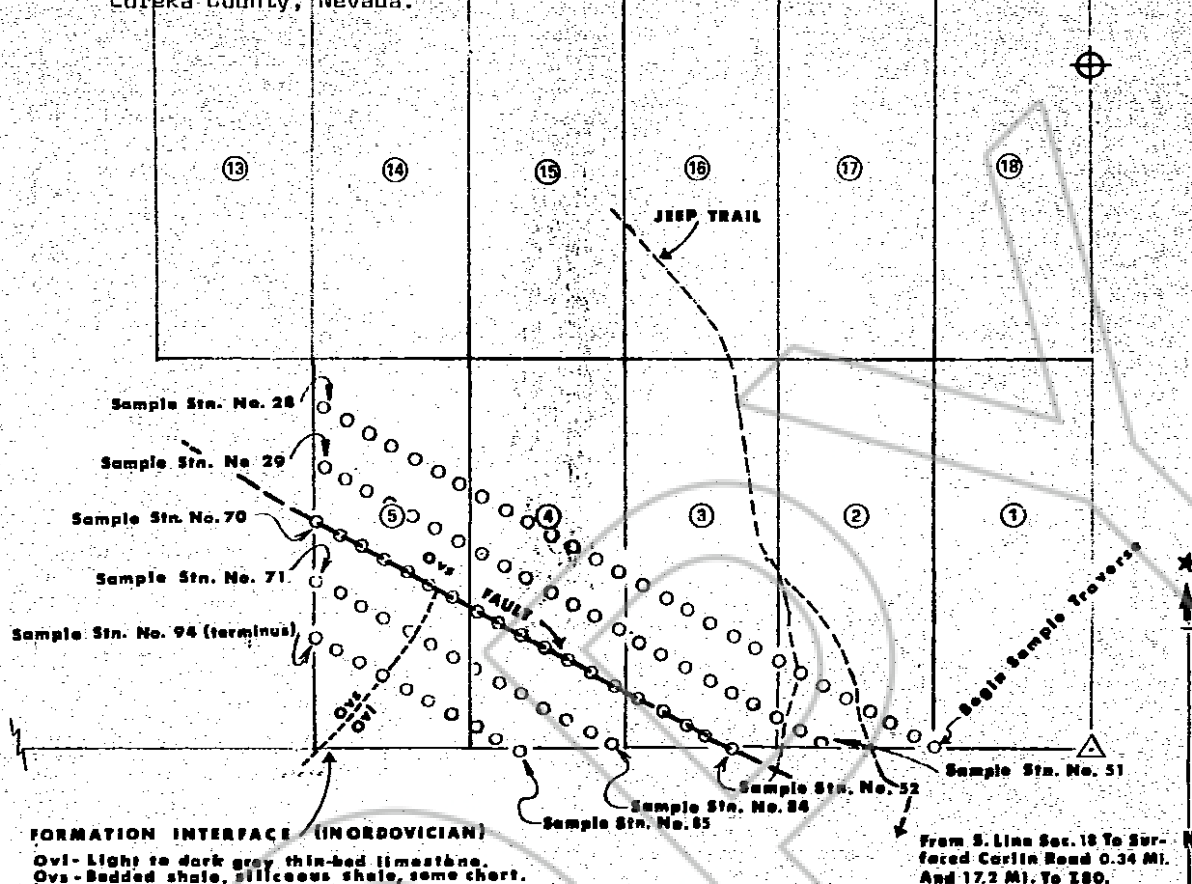
