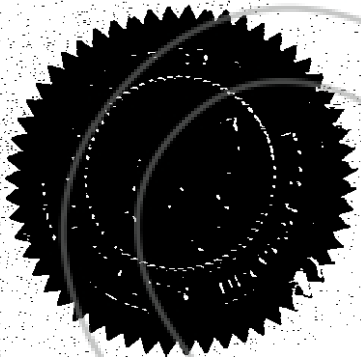

12 The matter of the hearing on the First and Final Account  
13 and Petition for Distribution of the Estate of Antone Rossi, also

5 And no written objections having been filed to the hear-  
6 ing or to the settlement of said account or to the granting of said
