ASSUMPTION AGREEMENT

THE UNDERSIGNED, having acquired title to that certain real property described in the Deed of Trust dated September 13, 1973, recorded in the Office of the County Recorder of Eureka County, State of Nevada on September 24, 1973, in Book 46 of Official Records, at page 325 executed by WOODROW J. RABER and VIRGINIA L.
