17 1. That WALTER H. RICHARDS died in Clark County, State
18 of Nevada, on the 15th day of October, 1972.

19 2. That said Decedent died intestate.

20 3. That the heir-at-law of the Decedent is as

25 4. That the gross value of Decedent's estate is less
26 than \$5,000.00. That the real property situate in the County of

27 2. That there be, and hereby is, allowed and paid to
28 EVANS and BILYEU, Attorneys for said Estate, the sum of \$75.00;
29 that said Attorneys be reimbursed the sum of \$6.00 costs advanced
30 on behalf of said Estate.

31 3. That Petitioner, having waived the right to the
32 payment of fees and services performed for said estate, none are
33 hereby allowed by the Court.

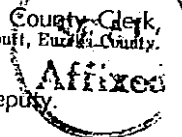
