JOINT TENANCY DEED

2 THIS INDENTURE<sup>o</sup> made this 10<sup>th</sup> day of January, 1975, by and  
3 between R. P. CAMPBELL, of Eureka, Nevada, hereinafter referred to as  
4 "Grantor", party of the first part, and R. P. CAMPBELL AND FRANCES M.  
5 HENNEMAN<sup>o</sup> hereinafter referred to as "Grantees", parties of the second

9 That the said Grantor, for and in consideration of the mutual benefits  
10 to be received by both parties, and other and further valuable considerations,  
11 the receipt whereof is hereby acknowledged, does hereby grant, bargain,  
12 and convey unto the said Grantees, in joint tenancy and to the survivor of them  
13 and to the survivor forever, all those certain lots, pieces or parcels of land  
14 situate, lying and being in the town of Eureka, Nevada, and bounded and  
15 more particularly described as follows, to-wit:

17 Lot Thirteen (13) in Block Five (5) of the Town of  
18 Eureka, Nevada, as described on the official map  
19 or plat of the Townsite of Eureka, Nevada, approved  
20 by the United States General Land Office on November  
21 19, 1937, on file in the Office of the County Recorder of  
22 Eureka County, Nevada; and, together with all improvements  
23 situate thereon.

24 TOGETHER with all and singular the tenements, hereditaments,  
25 improvements and appurtenances thereunto belonging or in anywise apper=  
26 taining and the reversion and reversions, remainder and remainders, rents  
27 issues and profits thereof.

28 TO HAVE AND TO HOLD the said premises,, together with the appur=  
29 tenances, unto the said Grantees, in Joint Tenancy and to the survivor of  
30 them forever.

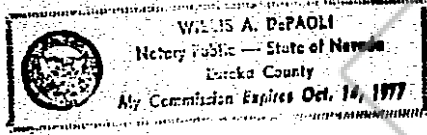
