

# Certificate of Location of Lode Mining Claim

The claim is 1500 feet long and 600 feet wide, and 1456 feet is claimed in a Northerly direction and 50 feet in a Southerly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the Northerly to the Southerly.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by 12x4 x 4 x 4 - red tap.

Corner No. 4 is a 4 x 4 x 4 post N.E. corner - red tap post  
Corner No. 5 is a 4 x 4 x 4 post side center - red tap post  
Corner No. 6 is a 4 x 4 x 4 post - S.E. corner - red tap post

The monumentation and marking of the corners was completed by the 31st day of January, 1975.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Gurucha County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
