

RESIGNATION AND ACCEPTANCE
OF RESIGNATION OF CO-TRUSTEE

WHEREAS, SIERRA PACIFIC POWER COMPANY, a Maine corporation (hereinafter called the "Predecessor Company"), entered into an Indenture of Mortgage dated as of December 1, 1940 (said Indenture of Mortgage as amended and supplemented being hereinafter called the "Indenture") with THE NEW ENGLAND TRUST COMPANY, a Massachusetts corporation as trustee and LEO W. HUEGLE as co-trustee; and

WHEREAS, SIERRA PACIFIC POWER COMPANY, a Nevada corporation (hereinafter called the "Company") has succeeded to the Predecessor Company as a party to the Indenture, NEW ENGLAND MERCHANTS NATIONAL BANK, a national banking association (hereinafter called the "Trustee"), has succeeded to THE NEW ENGLAND TRUST COMPANY as trustee under the Indenture, and FLETCHER C. CHAMBERLIN of Sherborn, Massachusetts, whose mailing address is 28 State Street, Boston, Massachusetts 02109 (hereinafter called the "Co-Trustee"), has succeeded to LEO W. HUEGLE as co-trustee; and

WHEREAS, Section 15.20 of the Indenture provides that the Company and the Trustee may accept the resignation of the Co-Trustee and may, in the event of such resignation, appoint a Successor Co-Trustee; and

WHEREAS, said FLETCHER C. CHAMBERLIN desires to resign as Co-Trustee under the Indenture and the Company and the Trustee, pursuant to the provisions of Section 15.20 of the Indenture, are willing to accept such resignation.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

The undersigned, FLETCHER C. CHAMBERLIN, hereby resigns as Co-Trustee under the Indenture.

The Company and the Trustee, pursuant to the provisions of Section 15.20 of the Indenture, hereby accept the resignation of FLETCHER C. CHAMBERLIN as Co-Trustee under the Indenture.

In order to facilitate the recordation and filing hereof, this instrument may be simultaneously executed in any number of counterparts and each of such counterparts shall, for all purposes, be deemed to be an original and all such counterparts shall together constitute but one and the same instrument.
