THIS NOTICE AND AGREEMENT, made this 10 day of December

1974, between CHARLES B. THORNTON (OWNER) and N L INDUSTRIES, INC.

(BAROID DIVISION),

WHEREAS, OWNER is the owner of certain lands in Eureka, Elko and
Lander Counties, Nevada known as T Lazy S Ranch; and

WHEREAS, OWNER acquired by patent in 1969 certain lands from the United States Government which are traversed by a certain road known variously as Boulder Valley road and Rossi Haul road; and

WHEREAS, BAROID acquired certain rights in an agreement dated February 27, 1947 by and between Horseshoe Cattle Company, a Nevada corporation (a predecessor owner of T Lazy S Ranch) and National Lead Company, a New Jersey corporation (predecessor company to N L Industries, Inc.); and

WHEREAS, BAROID constructed the road known variously as Boulder Valley road and Rossi Haul road and has been using same since 1947, and desires to continue using said road, including those portions traversing the additional lands acquired by OWNER in 1969, for haulage of barite from BAROID's Rossi Mine to its Mill at Dunphy, and for other normal business use; and

WHEREAS, OWNER has agreed by Agreement dated as of this date to convey to BAROID a further easement to use and maintain said road, all as hereinafter set forth,

NOW, THEREFORE, in consideration of the promises of each to each, OWNER does hereby give and grant to BAROID the further right and privilege to use that certain road delineated on Exhibit A attached hereto for haulage of barite from BAROID's Rossi Mine to its Mill at Dunphy, and for other normal business use and further the parties agree:

BAROID agrees that upon the final cessation of its said mining and milling operations it shall execute a quitclaim deed to OWNER regarding its rights in said road; or at the option of OWNER,

OWNER may execute and record a "Notice of Cessation of Use" which shall state that it shall become effective sixty (60) days after a copy and notice of recording thereof have been given to BAROID by registered or certified mail, unless a notice of objection is executed and recorded by BAROID within the above sixty (60) day period.

This Agreement shall be binding upon the parties, their successors and assigns. Assignment by BAROID shall be made only to lessors, purchasers or other successors of BAROID's said mining and milling operations.
