

1 THIS DEED OF CONVEYANCE executed this 16<sup>th</sup> day of  
 2 April, 1975, by and between CIRIACO HERRERA, hereinafter  
 3 referred to as the Grantor, and and CIRIACO P. HERRERA and ROSE C.  
 4 HERRERA, his wife, hereinafter referred to as the Grantees.

5 W I T N E S S E T H:

6 That the Grantor, for and in consideration of the sum of  
 7 Ten Dollars to him in hand paid by the Grantees, the receipt  
 8 whereof is hereby acknowledged, does by these presents, GRANT,  
 9 BARGAIN, SELL and CONVEY unto the Grantees, their heirs and  
 10 assigns forever, all that certain real property situate in Eureka  
 11 County, Nevada, more particularly described as follows, to-wit:

12 A segment of Block 38, Survey No. 128B of the  
 13 official General Land Office plot of Eureka  
 14 Townsite, Eureka, Nevada, embracing a portion  
 15 of Township 19 North, Range 53 East, Mount  
 16 Diablo Meridian, and more particularly described  
 17 as follows:

18 Beginning at a corner (a brass cap) marked AP 1,  
 19 General Land Office Survey, from which corner  
 20 No. 4 of the same lot (Block 38) bears N. 14°  
 21 45' W., a distance of 300 feet, and the NE corner  
 22 of Block 21 bears S. 10° 45' E., a distance of  
 23 32 feet; thence from said corner AP 1 N. 14° 45'  
 24 W., a distance of 150 feet; thence S. 78° 15' W.,  
 25 a distance of 260 feet; thence S. 14° 45' E., a  
 26 distance of 150 feet; thence N. 78° 15' E., a  
 27 distance of 260 feet to the place of beginning,  
 28 the premises herein described containing 39,000  
 29 square feet or 0.89 acres of land, more or less,

30 TOGETHER with all and singular the tenements, hereditaments  
 31 and appurtenances thereunto belonging, or in anywise appertaining,  
 32 and the reversion and reversions, remainder and remainders,


